THE TREND

Natural Rubber (NR) Production in the country during October 2010 decreased to 82,400 tonnes as against the production of 88,775 tonnes during October 2009 due to heavy rain. The cumulative production during the first seven months of 2010-11 was 457,650 tonnes compared to 437,400 tonnes during the corresponding period of the previous year registering a growth of 4.6%. The provisional estimate of NR production for November'10 is 90,500 tonnes.

Consumption of NR by the rubber goods manufacturing industry in the country during October'10 was 81,180 tonnes as against 80,500 tonnes during September'10. The total consumption during April'10 to October'10 was 550,230 tonnes

compared to 534,315 tonnes, recording a growth of 3.0 percent. The growth in consumption by the auto tyre sector during the first seven months of the current fiscal year was 5.4% as against 5.9% during the same period of the previous year. The consumption provisionally estimated for November'10 is 78,500 tonnes.

The country imported 18,149 tonnes of NR during October'10 compared to 100,11 tonnes during October'09. The aggregate import of NR during the first seven months of 2010-11 was 132,725 tonnes as against 132,106 tonnes during the corresponding period of the previous year. Export of NR during October'10 was only 180 tonnes compared to 2,274 tonnes during October'09. The total export of NR during April'10 to October'10 was

4,738 tonnes as against 3,865 tonnes during the same period of the previous year. Stock of NR at the end of October'10 was 248,355 tonnes.

Production of Synthetic Rubber (SR) during October'10 decreased to 8,726 tonnes from 9,245 tonnes during September'10. The total production of SR during April'10 to October'10 was 62,057 tonnes compared to 61,393 tonnes during the same period of the previous year. Consumption of SR slightly increased to 34,825 tonnes during October'10 compared to 34,480 tonnes during September'10. The cumulative consumption of SR during the first seven months of 2010-11 increased to 236,450 tonnes compared to 186,365 tonnes during the corresponding period of the previous year.
