THE TREND

Natural Rubber (NR) production in the country during January 2010 increased to 97,500 tonnes compared to the production of 91,900 tonnes during January 2009. The cumulative production during the first ten months of 2009-10 was 729,250 tonnes compared to 767,905 tonnes during the corresponding period of the previous year, registering a negative growth of 5.0%. The production provisionally estimated for February'10 is 51,500 tonnes.

Consumption of NR during January'10 slightly increased to 80,500 tonnes from 80,250 tonnes during December'09. The total consumption during April'09 to January'10 increased to 775,565 tonnes compared to 726,000 tonnes during the corresponding period of the

previous year, registering a growth of 6.8%. During the first ten months of the year 2009-10, the auto-tyre manufacturing sector showed a growth of 12.3% as against 4.1% during the corresponding period of the previous year. The consumption provisionally estimated for February'10 is 75,500 tonnes.

Rubber goods manufacturing industry in the country imported 7,645 tonnes during January'10 compared to 5,153 tonnes during January'09. The quantum of import of NR during the first ten months of the year 2009-10 was 147,745 tonnes as against 68,605 tonnes during the corresponding period of the previous year. The country exported 2,716 tonnes of NR during January'10, whereas the export of NR during January'09 was 1,475 tonnes. The

total export of NR during April'09 to January'10 was 13,252 tonnes as against 42,707 tonnes during the corresponding period of the previous year. Stock of NR at the end of January'10 was 286,920 tonnes.

Production of Synthetic Rubber (SR) during January'10 increased to 10,249 tonnes from 8,912 tonnes during December'09. The cumulative production of SR during the first ten months of the year 2009-10 increased to 89,512 tonnes compared to 80,196 tonnes during the same period of the previous year. Consumption of SR also increased to 33,445 tonnes during January'10 as against 31,725 tonnes during December'09. The consumption of SR during April'09 to January'10 increased to 281,965 tonnes compared to 242,255 tonnes during the corresponding period of the previous year.
